MESSAGE FROM THE CHAIR



This has been an excellent year for the Committee for Sydney. The Committee has been an important contributor to an extraordinary city at a particularly important and exciting time. The projects and planning currently

being undertaken in Sydney will affect the city's growth, prosperity and the lives of its citizens over the next century and the Committee is proud to be playing a key role in this.

As we noted in our benchmarking report *"First Amongst Equals?"*, there are very few cities in the world, and no other cities in the Southern Hemisphere, that share Sydney's remarkable combination of environmental, social, economic, education, health, commercial and cultural advantages. There are some significant issues that need attention – public transport, infrastructure and housing affordability – but increasingly the task for Sydney is to preserve and enhance its manifest advantages and to ensure that, as it grows, the city lives up to its extraordinary promise and reputation. The Committee remains focused on this task.

This year we are celebrating our first philanthropic partnership with Sydney Community Foundation. We are proud to support an organisation that shares our love of Sydney and strives to create an inclusive city that provides opportunities for all Sydneysiders to thrive.

In our recently completed membership survey, to which there was an 85% response, almost all described the effectiveness of the Committee over the last year as being either 'very strong' or 'strong'. This is good news for a membership organisation. The Board and team will always seek to remain relevant and useful to our diverse and growing membership, as both a network and also as a platform for civic dialogue and collaboration across the public, private and not for profit sectors. Our effectiveness is also measured by the extent to which key stakeholders embrace our work and implement the changes we think the city needs. This Annual Report seeks to provide a record of our activity and success in shaping the city's future. I hope you will agree that we are making an important difference.

Sydney needed greater metropolitan coordination, so we pushed for the creation of the Greater Sydney Commission, an Australian first. Sydney needed a fintech accelerator, so we helped to create Stone & Chalk, perhaps only the second such institution in the world. Sydney needs new sources of funding for infrastructure and policies to utilise existing infrastructure more efficiently, so we have promoted a greater understanding of value sharing and road pricing. We have pushed for Western Sydney to get the policy, investment focus and public transport needed to transform community outcomes and deliver the region's full potential to Sydney, and to Australia. We now see agencies of all tiers of government identifying the region as a priority with transformative new projects being proposed to exploit the city-shaping opportunity of the new airport which we also campaigned for.

In the last year we have provided intellectual and practical leadership, and fostered the public-private collaborations needed to deliver necessary policy development and change in critical areas. These include: a new drive to provide affordable housing; ensuring Sydney remains a city for all; greater recognition of the role of arts and culture in promoting our global city; the need for the growth of Sydney to be based on principles of 'density done well' and deep community engagement; the need to benchmark Sydney's performance against international competition; the drive towards a more data-driven city; and the shift to bigger, more empowered councils. We have also emphasised the role of cities as economic drivers for Australia and the need for new policy to support them. In particular, we have drawn attention to the contribution that Sydney's innovative financial, professional and ICT sectors make to national wealth, and the role of our world class universities in attracting global talent and investment.

The Committee's independence and the diversity of its membership are key to its success. We advocate for the whole of Sydney, and our wide geographic and sectorial focus is reflected in our membership, which continued to grow in 2016. We now have around 130 members drawn from the health, education, business, government, affordable housing, cultural and not-for-profit sectors. The quality and diversity of our membership makes the Committee a true civic alliance which can offer its great intellectual, technical and practical capacity to Sydney. The size and strength of our membership ensures the sustainability of the Committee and gives us the capacity to build our team and extend our reach. It also enables us to hold our membership fees at the existing levels, which have remained unchanged for four years.

In my first year as Chair, I have benefited greatly from the support of our Deputy Chairs Sally Loane, Michael Zorbas and the Hon Warwick Smith AM. I am extremely grateful for their engagement, support and wise counsel during the year. I would also like to thank our Executive Board members and the Chairs of each of our Taskforces who have devoted significant time and energy to the success of the Committee.

As a Committee, we have been extremely well served by a talented team of professionals lead by Tim Williams. At the time of the AGM, Tim will be completing his fifth year with the Committee and under his leadership the Committee has dramatically increased its leadership, membership, influence and impact. I look forward to working with Tim and the team as we continue our work on our 2016-2017 Priorities.

Recently we said farewell to two longstanding staff members, Johanna Pitman and Hannah Lloyd Hensley, both of whom are leaving the team but will remain close friends of the Committee. I would like to thank them for their very significant contribution to the work of the Committee over many years. We wish both of them well in their new roles.

Finally, on behalf of our Board, I would like to thank our members who have devoted so much energy, time and other resources to the work of the Committee over the last year. It is our members that ensure the success of the Committee, and ultimately, the success of Sydney as a vibrant, prosperous and smart city. My Board colleagues and I look forward to working with you in the year ahead as together we play a role in the shaping of Sydney's future.

A final note about Sydney. Our own research was amongst the first to call the turnaround in the city's economic performance around 2012. The momentum continues. Sydney is doing well and we celebrate this in all our work. But we also know that Sydney is not 'done'. The best cities look to reinvent themselves when they are winning. We must keep up the reform and investment program for Sydney and not go backwards from this point. The Premier once described us as 'challenging Sydney to be great'. We will continue that challenge in the year ahead.


COMMITTEE HIGHLIGHTS 2016

The Committee has been described by the NSW Premier as 'challenging the city to be great'. That means that although we are first to celebrate the excellence and successes of Sydney, we also always seek to raise the bar on our city's performance. We do this through researching the key issues for Sydney, exploring and exploiting global best practice and international expertise and advocating what we see as the reforms, policies and initiatives which will make a good city great. While we are proud of the quality and robustness of our Issues Papers and Submissions - enabled by our members' input - our objective is to promote a better informed civic dialogue and also, fundamentally, to persuade decision-makers to turn good ideas into action.

We believe that in 2015-16 the Committee, aided by members and stakeholders, had significant impact and cut-through in our current priority areas. Highlights include:

A CITY FOR ALL: MANAGING SYDNEY'S GROWTH

- Strategic planning and governance: The Committee helped initiate and shape the Greater Sydney Commission, which formally started work in January 2016. We have continued to assist the Commission and we will celebrate its first year of work with its Commissioners at the AGM reception. The GSC is a game-changer for Sydney.
- Governance: The Committee has long advocated local government amalgamations to make councils stronger, better resourced and more strategically enabled a journey which should also lead in time to an end to rate-capping. The amalgamations process is now underway. Combined with the GSC, the governance of Sydney is being transformed.
- Cross-government collaboration and innovation: The Committee helped introduce and socialise the City Deals concept from the UK now being implemented in a collaboration between the Federal and State government. This will see new investment in public transport in, and greater policy coordination for, our cities.

- Western Sydney: The Committee has since its renewal in early 2012 identified Western Sydney as crucial to Sydney's future, promoting the area for investment and developing governments' strategic thinking about the challenges and opportunities of the region. We have helped to shape a new planning, economic and transport focus on Western Sydney by state government and contributed to the emerging City Deal for Western Sydney.
- Housing and urban design: The Committee has shown what one stakeholder calls 'tenacious advocacy' around affordable housing, which has had its impact on government initiatives such as the Social and Affordable Housing Fund, Communities Plus, the proposed stock transfer to Community Housing Providers and the place of affordable housing in the planning system. At the same time, the Committee has had a high profile in the last 12 months and led the civic and professional dialogue on 'density done well'.

PROTECTING AND ENHANCING SYDNEY'S APPEAL

- **City benchmarking:** The Committee has benchmarked Sydney against competing global cities and promoted an awareness in government of the importance of benchmarking both to improving the performance and the marketing of Sydney
- **City branding:** The Committee has helped develop government thinking about city branding and identity, with a new approach to branding Sydney likely to be implemented in 2017
- City of Culture: We have identified Sydney's arts, culture and sports infrastructure and activities as central to its global city offer and contributed to the development of strategic thinking about them. We are developing a series of 'Sydney Culture Essays' to promote the city's excellence in the arts and established a Memorandum of Understanding with the Sydney Festival. We were very proud this year to have actively supported the 32nd Kaldor Public Art Project, stretching across 20,000 square metres of the Royal Botanic Garden, by Wiradjuri/ Kamilaroi artist Jonathan Jones.
- **Night time economy:** We have continued to research Sydney's night time economy and to work for it to become even more diverse, vibrant and safe.

KEEPING SYDNEY MOVING

- Public Transport: The Committee's strong advocacy for public transport investment continues to deliver results with many CfS-supported projects either progressing in the last year or being initiated: CBD and SE Light Rail, Parramatta Light Rail, Sydney Metro to Bankstown with the new station at Waterloo, commitment to a rail station at Barangaroo, Federal support for Western Sydney Airport rail connections and faster rail from Sydney CBD to Western Sydney. While we continue to advocate for a rail connection to the Northern Beaches we supported the bus rapid transit initiative there. The Committee has also helped promote new discussions around the possibility of high speed rail on the east coast, the need for a focus on transit oriented development and indeed the potential of the renewal of the Central Station precinct.
- Value Capture: While others also developed thinking around value capture, the Committee's research and advocacy has been influential in raising the importance of this approach to funding infrastructure and stressed its significance for public transport projects in the sense of supporting not just capital costs but also operational costs

- New approach to infrastructure appraisal: We believe our stress on the need for value capture to become part of a new approach to infrastructure appraisal, which currently ignores the benefits on land values and land uses of public transport, has had an impact on key stakeholders. Similarly our view that infrastructure appraisal needs to move away from a narrow focus on travel time reduction seems to have influenced the Federal Government's emphasis on a 'city-shaping' criterion for project appraisal of potential Western Sydney Rail options. We continue to work towards reform of appraisal.
- **Promoting ride-share and care-share:** We strongly supported the innovation in state regulation which enabled Sydney to become a global leader in ride-sharing services and welcomed the public-private collaboration, which has resulted in City of Sydney having a larger proportion of residents in car-sharing schemes than those of San Francisco or Boston.
- Road pricing and demand management: The Committee's Issues Paper, A Fork in the Road, was well received professionally, in the media and by reformers in both the Federal and State governments. There is now a serious policy debate about how, not whether, to implement some kind of pricing regime.

DRIVING SYDNEY'S PRODUCTIVITY AND COMPETITIVENESS

- From Stone & Chalk to the Financial Services
 Knowledge Hub: Having played a formative role in the creation of Sydney's not for profit 'fintech hub' the Committee, in partnership with the NSW Government, went on to establish the 'Financial Services Knowledge Hub' with an advisory board of eminent leaders in financial services providing expertise and leadership. The Hub has issued reports on government support for the startup ecosystem and regulatory barriers to fintech and supported the fintech internship program at Stone & Chalk.
- Innovation Districts and Jobs for NSW: Much of the current policy discussion in Sydney on innovation districts has been informed by Committee research and advocacy. As a result of its work and role in public private collaboration around enterprise, the Committee has been involved significantly in the Jobs NSW initiative of the NSW Industry Department and the Federal Government's National Innovation Agenda.

THE DATA-DRIVEN, RESPONSIVE CITY

- **Promoting Smart City thinking:** The Committee has, through its events program, publications and taskforces, been promoting the adoption by government/s of Smart City technologies and strategies. Our influence can be seen in the Federal Cities Plan with its \$50 million fund for Smart Cities and Suburbs program which our CEO helped launch. 'Government in a digital era' is a significant Committee priority as part of its drive for Sydney to be a 'data-driven and responsive city'.
- **Greater Sydney Dashboard:** The Committee's #wethecity series of Issues Papers has helped shape the GSC's emerging 'digital dashboard' for Sydney as platform for both reporting key city performance data and engaging with Sydneysiders.
- GovHack: The Committee sponsored an award at this annual open data competition for ideas around a 'Vibrant Sydney Night Time Economy'. Our prize went to Datacake, a team from UTS' Masters of Data Science and Innovation course, for their 'Lighthouse' solution that uses crime, traffic, demographics and business data to provide safe routes on the street at night.

GLOBAL PERSPECTIVES FROM INTERNATIONAL EXPERTS

The Committee has long been dedicated to bringing international expertise and best practice to Sydney, and this year has been no different. Highlights include:

- Professor Greg Clark OBE: Building on the success of last year's visit, the OECD advisor and UK-based global cities expert visited twice, advising not only the Committee but also NSW Department of Planning, Greater Sydney Commission and the Federal Government.
- Geoff Mulgan: The CEO of the National Endowment for Science, Technology and the Arts (Nesta UK) visited Sydney to discuss smart cities, social innovation and investment, start-ups and the role of government in innovation ecosystems.
- Erin Barnes: The Founder of ioby (In Our Backyard) visited Sydney from the US to share her

experience in building a model of positive community-driven delivery of urban renewal at the local level.

- Sir Robin Wales and Tony
 Clements: Hailing from the
 London Borough of Newham,
 home to the 2012 London
 Olympics, Mayor Wales and
 his Assistant Chief Executive
 demonstrated the power of
 leveraging major events for
 local growth, and the innovative
 approaches Newham is taking to
 tackle housing un-affordability.
- Jeff Speck: The walkability expert and author of *Walkable City* visited Sydney to discuss the benefits of walkability for cities, and practical tools for delivering

walkability to both new and existing areas for social and economic uplift.

- Isabel Dedring: The transport expert and former Deputy Mayor to Boris Johnson, now Global Transport Leader for Arup, visited Sydney to share her lessons learned in delivering major transport projects in London, and discuss the case for value capture in cities.
- Madam Chen Linfang: The Director and President of Public Affairs and Communications at Huawei in China visited Sydney and met with members of the Committee and its Financial Services Knowledge Hub.


MEMBER ENGAGEMENT

The Committee conducted a member survey in 2016 to understand how members are engaging with Committee activities and advocacy and what aspects of the Committee's work are most valuable to the membership. Results of the survey indicate that members are highly satisfied with the Committee's performance, with 94% of members rating the Committee's performance as strong or very strong.


The Committee's commitment to bringing international expertise and best practice to Sydney is valued by the membership, with events featuring international speakers rated highly. More than a third of respondents attended 4 or more Committee events in the last 6 months, and 94% reported that they pass on invitations for events when they cannot attend. More often than not, the Committee engages with more than one person within its member organisations. Taken together, these results suggest that the Committee has deep relationships and also extends its reach within member organisations.



The Committee has seen real growth in media coverage this year. Since the 2015 AGM, 12 Op Eds have been published by the Committee team, covering topics including:




We have continued to present a balanced approach to media activity, working to ensure our messages reach a broad audience across Greater Sydney. We enjoyed hosting the Editor of *The Daily Telegraph*, Chris Dore, for a high level Boardroom lunch event in September.

The Committee's media mentions have grown, increasing from 136 in the year to the 2015 AGM to 196 this year. Media coverage grew particularly strongly in *The Daily Telegraph*, almost doubling last year's coverage. The Committee has strengthened its position as the independent 'go to' organisation for intellectual, evidence-based thinking on Sydney policy.


As with last year, peaks are observed coinciding with the release of Committee reports and accompanying media activity.


